2. Discuss, consider, and consider recommendation from the Copper Canyon Planning and Zoning Commission regarding Williams Ranch Final Plat, Construction Plans, TxDot Application, CCR's and related documents, for (20.098 acres in the William Biles Survey, Abstract No. 120 Town of Copper Canyon, Denton County, Texas) and all matters incident and related thereto.

Mayor Robertson stated that Copper Canyon's P&Z approved the Final Plat for Williams Ranch with three conditions.

Deputy Mayor Pro Tem Castillo asked if the entrance had been approved. David Siciliano, Williams Ranch developer, stated that the entrance has been approved and deeded to the Town. He also stated that the plans for the entrance have been presented to TxDOT and they are waiting for approval.

Deputy Mayor Pro Tem Castillo asked if any consideration had been given to a deceleration lane due to heavy traffic on FM407. David Siciliano stated that **Town Engineer Hartke**, required an easement to be dedicated in the event TxDOT required the deceleration lane.

Council Member Johnson made a motion to approve the final plat for Williams Ranch with three conditions:

- 1. TxDOT approval of the driveway permit on FM407
- 2. TxDOT approval of the UIR permit for construction of the sanitary sewer line under FM407
- 3. Review and approval of the CCR and HOA Documents (based on the Town Attorneys review).

Deputy Mayor Pro Tem Castillo seconded the motion.
