Just the Facts about Copper Canyon by Mayor Ron Robertson November 2019

It has been another busy and productive month for the town of Copper Canyon.

As you may or may not know, the Town has existing bond debt of \$1.2 million for road work. The interest rate on the existing bond is 4.25%. The Town Council made a wise decision to "refund" (refinance) the bond due to the current low interest rates. Here is the breakdown:

Total of Bond: \$1,210,000

Original interest rate: 4.25%

New interest on refunded bonds: 1.78%

Savings to the town: \$137,366

Over the last 5 months, our Town Council has worked diligently with me reworking our budget to reduce costs in key areas. These areas include:

#1 Legal Fees

The former budget averaged \$70,000 in legal fees per year. Currently our projection is \$25,000/year for a savings of \$45,000/year equaling \$225,000 over 5 years.

#2 Engineering Costs

\$60,000/year was budgeted for engineering fees. Those fees are now budgeted at \$25,000 per year for a savings of \$35,000/year equaling \$175,000 in 5 years.

#3 Eliminating One Officer

\$616,000 savings over 5 years which includes the Denton Sheriff Office increases of approximately 5% a year.

#4 Refunding the Bonds

\$138,000 savings in interest over the term of the bonds.

These four areas alone will save the town of Copper Canyon approximately \$1,154,000.00 in the next five years. The total savings will be accumulated in the next 10 years which is a significant annual savings on an approximate \$975,000.00 operating budget. These budget item reductions are done in conjunction with other improvements for the town including combining road work to bring down costs, drainage studies to reduce flooding and improvements of technology at Town Hall. I want to personally thank the entire Town Council and Town Staff for supporting my policy and improving the long-term future of Copper Canyon.
