**DEFENDANT'S PLEA AND REQUEST FOR
DRIVER SAFETY COURSE AND MOTION FOR DISMISSAL**

I, the Defendant in the above cause do hereby enter my appearance, waive my right to a jury trial and presentation of a complaint, and enter my Plea of **NOLO CONTENDERE** to the offense of:

I, further request that the Court DISMISS this citation by allowing me to complete a Driver Safety Course as provided under Art. 45.0511 of the Texas Code of Criminal Procedure. I also understand that the Court will enter a finding of guilt, but such finding will be dismissed after a period of ninety (90) days from the date of this request PROVIDED that:

- Within 90 days, I present to the Court a certified copy of my driver's record from the Texas Department of Public Safety
- NO LATER THAN 90 DAYS FROM THE DAY OF THIS REQUEST, I will complete a Driver Safety Course approved by the Texas Education Agency; or if operating a motorcycle, a motorcycle operator's training course approved by the Department of Public Safety, and provide the ORIGINAL "COURT" copy of the uniform certificate of Driver Safety Course completion to the Court; and
- I must pay the State Costs and Administrative Fee to the Court on the date of my request.
- In support of my request for dismissal by completion of a Driver Safety Course, I HEREBY SWEAR AND AFFIRM THAT THE FOLLOWING STATEMENTS ARE TRUE:
- I am not in the process of taking a Driver Safety Course under Art. 45.0511 of the Texas Code of Criminal Procedure nor have I completed a Driver Safety Course which is not reflected in my driver's record as maintained by the Texas Department of Public Safety.
- I am not a commercial driver's license holder.
- I have not completed a Driver Safety Course for the dismissal of a traffic citation within the twelve (12) month period preceding the date of the alleged violation.
- I have provided a valid copy of (1) my Texas Drivers License and (2) proof of financial responsibility.

I understand that an Interim Conditional Judgment shall be issued by the Court and I understand that this offense will be dismissed after the ninety day period upon my providing: 1) proof of successful completion of a Driver Safety Course; and 2) a certified copy of my driving record within 90 days of the date of this request. I also understand that should I fail to provide the proof as required, the Court will require my appearance to show cause why the proof was not submitted timely. At the time, the Court may enter a judgment of guilt. If I fail to appear at the hearing, the Court will enter a judgment of guilt and the offense will appear as a conviction on my driving record. Plus, an additional fine of \$190 will be assessed and become due and payable.

I understand that my Driver Safety Course completion certificate and a copy of my Driving Record must be provided to the Copper Canyon Municipal Court, 400 Woodland Dr., Copper Canyon, TX 75077 on or before:
